Ryan Brandt nominated Liz Morris. Bill Ullrich seconded. There were no other nominations, Liz accepted.

<u>PLANNING AND ZONING</u> — Mark McCormack presented the Dillsboro Interlocal Agreement for very specific services. \$7,200.00 for 200 hours of work. The PAC (Allen Goodman and Dennis Kraus) recommends that the money amount be a little higher and that this not change salary in any way. Allen Goodman thinks that each contract should stand alone and Mark McCormack should not co mingle contracts. Liz Morris is concerned that the office is stretched a bit thin.

Ryan Brandt works for the town so he recused from any discussion or vote. Liz Morris would like to see the commissioner's act first. Kevin Lynch stated that he would be voting in the affirmative.

Motion to proceed with the Dillsboro Interlocal Agreement if adjustment of fee to \$10,000.00 is approved. Motion moved by Dennis Kraus Sr., seconded by Bill Ullrich. Charlie Keyes voted NAY, Ryan Brandt abstained. Motion passed.

Grant Agreement – Community wide bike and pedestrian trail master plan. Local match \$20,000.00. No funds to come from the county.

Motion to give permission to proceed with bike and pedestrian trail plan moved by Bill Ullrich, seconded by Dan Lansing. Dennis Kraus, Sr., voted NAY, motion passed.

REDEVELOPMENT COMMISSION – Jim Deaton presented the Skally's TIF Bond (Odette LLC) first reading in amount not to exceed \$800,000.00. Introduction of Drew and Effram of Skally's Old World Bakery. A family business of 38 years, 1st and 2nd generation and bringing up the 3rd and 4th generation that cares about the community and neighbors. Liz Morris expressed our pleasure in meeting them and that we are looking forward to doing business with them and thank you for coming tonight. They will be adding 40 or 45 jobs. Dallas Paul from site development. Questions: Copy of incentives for Dennis Kraus. Next to Hirlinger 36.5 acres, business personal property tax estimate is 35% as well as real prop tax. Umbaugh will email the tax impact statement.

West Harrison LLC is Maxwell Corporation –they will borrow money, they will manage the project for a certain %. This is a start and takes them to the next step. First reading Bond of \$3,000,000. Bond ordinance, financing agreement. Redevelopment would like to entice others to come to our area – this bond allows them to purchase land, money to buy property, opens up options for them to move forward. Leveraging property tax to pay for the bond rather than wait for cash in hand. Randy Maxwell spoke "this is a tool in that the redevelopment can borrow money backed by Skally's project", all risk is on the developer. Ryan Brandt commends the work of the redevelopment board in bringing business to our area. The bond will sit for a while until they move forward with lease. The redevelopment would like to be self-sufficient and not have to rely on County Council. Jason Semler, Umbaugh spoke about sending the TIF tax impact documents.

<u>Late Arrival</u>: Dennis Kraus Jr. presented a salary change for his part time person. This person works one day a week.

<u>AUDITOR</u> – Gayle Pennington presented Ordinance 2016-001 Authorizing Purchase of a Crime Insurance Policy. This would be additional coverage added to the original crime policy to cover employees who handle money.

Pursuant to IC 5-4-1-18c every employee that touches money must be bonded. The cost of a \$5,000.00 bond is \$100 per employee. The increase of Dearborn County's crime insurance policy will save the county money.

Motion to approve Ordinance 2016-001 Authorizing Purchase of a Crime Insurance Policy moved by Allen Goodman, seconded by Ryan Brandt. Motion passed unanimously.
