2021 Veteran Service Year in Review - Dave Currence

Dave Currence serves all Veterans and their spouses. Dave Currence was able to obtain a raise for the drivers last year. It has been 16-years since their last increase. On a sad note, an extra \$6,500 was needed for burial funds due to the Coronavirus impact. He was able to purchase 2 new Handicapped Accessible Vans for transporting our Veterans to their medical appointments. He has also hosted a benefits presentation at North Dearborn Library Branch. Commissioners thanked him for his service and all the good he does for our Veterans.

Building Department Update - Bill Shelton, Building Commissioner

There were 127 new home starts in Dearborn County in the year 2021. In 2021 \$210,425 was collected in fees. Largely due to commercial fees and the taking in of Lawrenceburg inspections. He started a new online permitting program and code enforcement, along with Planning and Zoning, Health and the Highway Departments. It allows our offices to interact more efficiently. He mentioned that he needs money for the Unsafe Building Fund.

Commissioners thanked him for all the work he does for the county.

Animal Control Update - Marlene Underwood, Animal Control Director

Marlene Underwood produced statistics for animal complaints, investigations, and runs.

She said she would be interested in the Sheriff's old canine vehicle. The Commissioners thanked her for the good work she does for the county.

# 911 Update - Jared Teaney, 911 Director

Jared Teaney had statistics on how many calls they received in 2021. It was a list showing what kind of emergency, the calls were concerning. There were 142 calls on June 18th, 2021 between 9:00pm & 10:00pm, this was the busiest hour of 2021. The commissioners asked in an emergency, could they still operate. Jared responded they have multiple options and could still operate. Jared also mentioned they try to get out for public education when they can. The Commissioners thanked him for everything he does for the County 911 system.
