Bright Volunteer Fire Department – Kendall Eberhart wanted to let Commissioners

Know that the department is in need of additional funding to operate. They are looking at maybe another 2 to 3 years of being able to sustain itself. They may not be able to sign contracts after that because of funding. They are unable to give raises or hire anyone because of the lack of funding. Currently they are covering approximately 25,000 people or half of the county population. He thinks maybe a Fire Territory or Fire District may be needed. Volunteerism is down so paid staff is necessary. He is trying to be as transparent as he can be. Jim Thatcher wants him to get the Alliance to come to budget hearings when more money is asked for. Rising fuel costs has also hurt the department, truck repairs are also a factor. He plans on going to County Council to ask for funding for another ambulance. He would like to be able to have enough funds in savings to purchase equipment on a regular basis. They are currently just able to maintain what they have.
