Overview of Life-Time Resources and Catch-A-Ride - Erin Thomas, Director

They stay very active in our community concerning the elderly. They provide care so the elderly can remain in their homes for a longer length of time. Rides to appointments are also provided by Catch-a-Ride. Life-Time tries to get the word out on what services are available to the public.

### Building Department- Bill Shelton gave an update.

The number of new homes were 120 in 2020, 127 in 2021and 99 in 2022. All the builders are still building homes. New homes are staying consistent in number. The new permitting system is stream lining permits. It also keeps the Health Department and Planning & Zoning in the loop. Carl Fryman is still doing the Weights and Measures.
