Tax Payment Made Through PayGOV

Credit Card transactions are made through PayGOV. There is a 3% service charge for the credit card transaction over \$100 or a flat fee of \$3.00 for transactions under \$100. Check to make sure all of your property information is correctly entered into the boxes. Enter the credit card information. Always print out a receipt for your records.



Visit the Beacon GIS Map property search website after a few days to ensure the property record indicates the taxes are paid. Contact the Treasurer's Office if you have questions on your tax payment.


Go to <u>www.beacon.schneidercorp.com</u> or click the pay property tax link on the Dearborn County website.

Select Dearborn County, IN from the drop down list. Make sure "Property Search" is checked, and then press "Enter".



Property Search

Search for a property by Name, Address or the 18 digit Parcel ID number (can be located from a tax bill).



Select Parcel Report

After a search has returned the results, choose a parcel by clicking the blue 18 digit Parcel ID number. (Note: This step will be skipped if only one parcel report record is returned after the search is completed.

After selecting the 18 digit parcel, it will pull up the report on the parent property.



GIS Mapping

To view the GIS map of the property, select "Map" in the top tabs. While in the mapping view, you can also select other properties by clicking on the parcel to view ownership information. Select "Report" to view the full property report on a new parcel.



Data Corrections

If you find incorrect information on the website, click on the speech bubble on the top right hand side of the page in the property report. This will allow you to send a correction on that particular property.

Beacon GIS Subscription

Subscription Payment

There are two subscription options: a monthly subscription of \$10 per month or an annual subscription of \$100. Payments can be made online and will take a minimum of 24 hours to activate the account.

In order to purchase a subscription, you must create an account or be logged into an existing account through the Beacon GIS website

Subscriptions

The Beacon GIS website for Dearborn County can offer a user with a large amount of information for property searches, but there are mapping layers and tools that can *only* be accessed by members of a subscription. Subscriptions are excellent for property appraisers, bankers, land-use attorneys, realtors, individual land owners, landlords, brokers, and many other professionals.
