PLEDGE OF ALLEGIANCE

Liz Morris read the title VI statement.

<u>PROSECUTOR</u> — Aaron Negangard said this will be his last meeting before he begins his new job as chief deputy to Attorney General Curtis Hill. Council thanked him for his years of service. The Dearborn County Prosecutors office will be combining the Wayne County Adult Protective with the other five counties that are a part of his region. The State will be adding \$125,094.00 to the Grant to bring this together. This region will now be a ten-county region. He is looking adding two new employees paid from the Grant.

Dan Lansing made a motion to approve at no cost to the County. Bill Ullrich seconded. Motion passed.

PARK BOARD

By letter of recommendation from the Park Board, Bill Ullrich made a motion to reappoint Jim Red Elk as the Council appointment to the Park Board. Allen Goodman seconded. Motion passed.

Jim Red Elk presented the advertised projects. Before the meeting, Celeste Calvitto wrote a check for \$3500.00 to the Park Foundation fund so no money is needed after all for playground improvements and refinishing signs.

County Farm improvements were approved out of the County Farm Capital Improvements \$19,200.00 out of Fund 1179. The Highway department will also help out by doing \$7,700.00 on the parking lot. The Improvement Fund will repay the Highway for the gravel.

JAIL - Sheriff Kreinhop ask for \$15,000.00 to cover Inmate Medical Care for the rest of 2016.

Ryan Brandt made a motion to approve \$15,000.00 from River Boat funds. Allen Goodman seconded. Motion passed.

<u>COMMISSIONERS</u> – Terri Randall presented a request to draw for Courthouse Annex Project. Council would like to see the funds that mature in January to stay invested so they only approved only \$1.4. Charlie Keyes asked for more information on the investments to be sent out. He has recommended that the Council meet more often during this project so the money can stay invested longer.

Bill Ullrich made a motion to approve \$1.4 M only of the \$5 M advertised. Allen Goodman seconded. Motion was approved. Dan Lansing voted NAY.

<u>REGIONAL SEWER DISTRICT</u> – Steve Renihan presented the Wilson Creek Project. They will be a partner in the project with the City of Lawrenceburg. \$84,670.26 is needed from the Sewer Fund.

Ryan Brandt made a motion to approve \$84,670.26 from Fund 4917. Allen Goodman seconded. Motion passed.

SUPERIOR COURT PROBATION / COMMUNITY CORRECTIONS - Steve Kelly

Judge Cleary has gotten a Grant to support a regional veterans court. Kristy Alig's salary will switch from the Community Correction Grant to the veteran court Grant. Her salary will be retro to the begin date of the Grant.

Ryan Brandt made a motion to approve at no cost to the County. Bill Ullrich seconded. Motion passed.

Kayla Griffin was promoted to case manager and her salary will be retro also.

Dan Lansing made a motion to approve at no cost to the County. Allen Goodman seconded. Motion passed.
