


# INTRODUCTION

**D**earborn County's location in Southeast Indiana, 30 minutes from Downtown Cincinnati and 15 minutes from the Greater Cincinnati/Northern Kentucky International Airport, helps make it an ideal place for doing business. As other counties in the Ohio-Kentucky-Indiana (OKI) Tri-State region continue to grow rapidly, and developable land becomes more scarce, Dearborn County continues to offer an abundance of undeveloped land, access to a good workforce, an unemployment rate below the national average, and the opportunity to work in a state that has been ranked by Chief Executive Magazine as the 5th best in the nation (and best in the Midwest) for doing business two years in a row.

Dearborn County seeks to have a resilient, diverse, sustainable economy—which results in a stronger, more vibrant tax base that can support new public infrastructure and services that its communities want and need. Dearborn County has also made expanded access to knowledge, education, and training opportunities for its workforce a high priority. Currently, roughly 60% of Dearborn County's residents / workforce members leave the county to go to work. With proper business growth, more of the community's residents can live and work closer to home—which would solidify and ensure Dearborn County's position as a great place in the Greater Cincinnati area to live, work and do business for years to come!







31% of Dearborn County residents over the age of 25 hold an Associate's Degree or higher. Dearborn County is home to 15 public schools (in 3 public school districts), 3 private schools, and 14 childcare & preschool establishments. The county is also home to the Southeast location of Ivy Tech (in Lawrenceburg), which is Indiana's largest postsecondary institution and is the nation's largest singly accredited statewide community college system (with a total enrollment of 91,179 in 2020). Ivy Tech Southeast's 2020 enrollment was 2,753 students.

### CINCINNATI/NORTHERN KENTUCKY INTERNATIONAL AIRPORT

While there are no public airports in Dearborn County, the Greater Cincinnati/Northern Kentucky Airport (CVG) is located approx. 15 miles from the county in Northern Kentucky. CVG is home to 7 passenger airlines as well as a major cargo hub for DHL and Amazon. CVG grew by 18% between May 2017 and April 2018—making it the fastest growing airport in North America in that time period. In December of 2017, CVG also set a record for cargo traffic.

## Interstate Highways

Dearborn County is served by two interstate highways. Interstate 74 runs east-west through the northern portion of the county through St. Leon and West Harrison and connects the county to the urban centers of Indianapolis and Cincinnati. Interstate 275 forms a full beltway around the Greater Cincinnati area that connects the southeastern part of the county to Ohio and Kentucky (including CVG) with an exit in Greendale.

## US Highways

There are also two US Highway routes in Dearborn County. US 50 travels through the southern part of the county, from Hamilton County, OH to the east through Greendale, Lawrenceburg and Aurora along the Ohio River, and runs somewhat parallel to the county's southern border until it passes Dillsboro and into Ripley County (to the west). *US 50 also provides gateway access to Interstate 275.* US 52 serves the northeastern corner of the county, connecting Franklin County to the north with Hamilton County to the east. *US 52 also provides access to Interstate*

## State Routes & Local Arterial Roads

In addition to Interstate and US Highways, there are also several state and locally-maintained roads in Dearborn County that serve as major arterial roads. There are 7 state routes that pass through the county and approximately 650 total miles of county roadways.

## Parks and Recreation

Dearborn County is home to over 20 parks, and 4 golf courses, as well as the Dearborn Trail, a 5.4 mile bike and walking trail that runs along the Ohio River through Greendale, Lawrenceburg and Aurora. Dearborn County is also home to popular attractions such as Perfect North Slopes, Hollywood Casino, Lawrenceburg Speedway, the Lawrenceburg Event Center, Hillforest House and Museum.
