MINUTES

Dearborn County Redevelopment Commission November 19, 2018

A meeting of the Dearborn County Redevelopment Commission was held at 9:00 a.m. on Thursday, November 19, 2018 in the Henry Dearborn room located in the Dearborn County Government Center, 165 Mary Street, Lawrenceburg, IN 47025. There was an Executive Session at 8:30 a.m. held in the same location.

Attending:

Jim Deaton, Dave Deddens, Jim Helms and Diane Bender were present for the board at both the Executive Session and regular meeting as well as Jamie Graf, non-voting school board member. Andrea Ewan, Board Attorney, and Terri Randall, One Dearborn attended both meetings. Sue Hayden, minute taker and Connie Fromhold, Treasurer for the Board attended the regular meeting only. Allen Goodman, board member arrived late for the regular meeting.

Jim Deaton, called the meeting to order at 9:15 a.m. and read the Title VI statement for compliance. Deaton also read the following Memorandum for Executive Session into record.

As indicated in the published Notice of Executive Session, the discussions during the Executive Session dealt with issues deemed confidential subject to Indiana Code IC 5-14-1.5-6.1(b) (2) (D) which pertains to discussing strategy with the respect to the purchase or lease of real property by the governing body up to the time a contract or option to purchase or lease is executed by the parties.

Action from Executive Session:

Dave Deddens made a motion to allow One Dearborn to engage Umbaugh run numbers for potential land acquisition. Jim Helms seconded. Approved.

CW will be looking at this as regional, or the Cincinnati area, but will engage with partners out of Indianapolis to help distribute material. This material will be sent electronically to over 3000 industrial users and also brokers, builders, developers. Tom gave an overview of CW and how their business is doing for the year. Per Terri some of the Duke site readiness money can be spent to pay for Beyer Becker to do some work conceptions.
