# Dearborn County Redevelopment Commission March 4, 2019

Attending:

Also attending both meetings were Connie Fromhold, Treasurer for the Board Terri Randall, One Dearborn. Andrea Ewan, Board Attorney participated via phone for the Executive Session only and Sue Hayden, minute taker attended only the board meeting. Allan Goodman was absent.

Jim Deaton, called the meeting to order at 10:00 a.m. and as no public was in attendance noted the Title VI statement would not be read. Deaton read the following Memorandum for Executive Session into record.
