Dearborn County Redevelopment Commission July 2, 2020

A meeting of the Dearborn County Redevelopment Commission was held at 10:00 a.m. on Thursday, July 2, 2020 in the Henry Dearborn room located in the Dearborn County Government Center, 165 Mary Street, Lawrenceburg, IN 47025. An Executive Session took place at 8:00 a.m. held at the same location.

Mike Perleberg and Terri Randall from One Dearborn attended the regular meeting.

A claim was presented for landscaping around the US 50 Business park in the amount of \$600.00 by Drake Lawn & Landscape. This is to be paid from the W. Aurora TIF. Motion to pay claim made by Allen Goodman with a second by Jim Helms. All approved.

Old Business:

Jim Deaton brought up the request made by Whitewater Mill regarding any incentives that could be made for their construction of new silos for storage. Mike Perleberg recently met with them and informed the board that the project had moved forward and the request was no longer needed.

New Business:

2021 Budget - No changes from last year. Jim Deaton motioned to approve budget with a second from Dave Deddens. All approved.

Annual TIF Report Presentation – Terri Randall, One Dearborn presented the Annual Report that is required by State Statute. She explained this report along with other needed to be uploaded to the Indiana Gateway. There is also a requirement to present this in a public hearing for review and to allow for questions. Mike Perleberg did an update on what they have been working on which include: business attraction, Blight Elimination Program with Nicole Daily, Zoning Administrator for Dearborn County, W. Harrison TIF area signs and their condition, removal of a downed tree on the W. Harrison blighted property, REDI Cincinnati drone video and the Trails Report. They have been networking with others and discovered meat processing issues and are working on this through a regional prospective.
